Chairman's Topics

It was with a lot of sadness that we learnt that Max Hageman, who has been such a support to the town and particularly the Association, is moving to Dorset to be near to his family. Some of our younger members will not be aware that it was Max who designed our logo. Although I have obviously written to him personally I could not let my report start without thanking him on behalf of the Association for all his hard work, including the posters, over the years.

It is personally very pleasing to see the various large developments in the town particularly at Manor Street/Ravens Lane and at the old garage site progressing towards completion. This is especially as the former has taken so much of my time sitting on the fortnightly meetings with Laings, the CARAB group and Town/Borough Councillors. Now that the contamination has been removed, the site is a straightforward building site and meetings are planned to be only 2 monthly.

The latest hot potato are the plans to change the parking arrangements in the town and by the time you get this newsletter the public exhibitions may have taken place. I would encourage all members to put their thoughts to the Borough Council and if members want to feed them through me I would be grateful. We have started to look at the initial proposals to set up Regional Assemblies and John Parsons, our latest committee member taking a close interest. As we understand it, the proposal is to lump us in with East Anglia to create an Eastern province with HQ at, say Norwich. Our personal positions are easing towards leaving the county structure as it is. But can we have your thoughts.

On a personal level I had not realised that being Chairman was such a dangerous occupation, as when I returned from holiday I found that our house and nearly new car had been pelted with eggs and flour on 2 occasions. Norman has lived in the town for most of his life, arriving at the age of 2 weeks to live in one of the 'pre-fabs' at the top of Three Close Lane and has lived at his present home for over 20 years.

He attended Ashlyns School prior to serving a 5 year apprenticeship with Eastern Electricity as an electrician. After spending a couple of years as one of the emergency electricians (those who attend at all hours to sort out electrical problems) and working for a local shopfitting firm, he started his own electrical contracting business in 1972.

In 1995, against his wife's better judgment, he stood for election to both Town and Borough Councils. Much to everyone's surprise, was elected.

During his time on the Borough Council, he was a member of numerous committees, including Development Control, Housing, Environment and Policy. On the Town Council, a member of the Planning, Transport & Highways and Finance & Policy Committees.

He also started the first non-commercial Berkhamsted Internet web site (http://www.berko.org.uk) which is still updated on a weekly basis.

The ward boundary changes in 1999 effectively put him out of office as an Independent Councillor, but still takes an interest in local political matters - after all, he lives and works here.

Town Amenities Sub-Committee

As I write this report it is the end of August and where has the summer and indeed the controversial planning applications gone. Normally as the planners get out their open toed sandals (to be worn with black socks) out of the wardrobe, cancel the Guardian and prepare for 3 weeks in the south of France every developer worth their salt whacks in that dodgy plan. This year has been a quiet time and our committee meetings have been short. We were however not happy with a proposed development at 2 Meadow Road as we viewed it as over-development of the plot and having a blank wall facing the road.

Regarding the proposed new site for the Hospice of St Francis, although we would normally object strongly to any development into greenbelt, but the fact that it is a "brownfield" site and would not be visually obtrusive we have supported the application on an exceptional basis.

We were pleased to hear that Tesco, who had put in an application to erect new signage when they convert the store to a Tesco Metro outlet, had taken notice of Town Councillors objections and put in a new plan to reduce the size of the signs.

On a final note the footpath map still sells well at The Bookstack and The Complete Outdoors in Bourne End and it will not be long before a reprint is needed and we will try and get better quality paper next time.

The Associations Contribution to the Jubilee John Cook writes:

In the last issue of the Citizen, we were only able to include the bare results of the competition, organised and funded by the BCA, that was our main contribution to the town's celebration of the Jubilee.

The competition was for schoolchildren, and the subject was chosen to allow boys and girls to express what the occasion meant to them, as young citizens of Berkhamsted or Northchurch, using any medium of their choice. Two prizes were on offer, one for a child in a first school and the other for a child in a middle school (or their independent sector equivalents).

Not all schools responded, but the children of those that did, put in such a quantity of high entries that the judges had their work cut out to pick the winners. In the end, the panel were unanimous in awarding the prize for the 5 to 9 age group to 7 year old Richard Timms from Swing Gate School for his remarkable moving poem. The 9 to 13 age group winner was 13 year old Emily Stidston of Egerton-Rothesay School for a beautifully worked drawing, also incorporating a poem.

They were each presented with a cheque for £50 from the Association at a small ceremony during the Jubilee Celebration at the Berkhamsted Cricket Club's ground, and at the same time a similar amount went to each of their schools.

September is Parking Consultation month

Norman Cutting has a view:

Let me see if I've got this right.

In order to solve the car parking problem, the Borough Council have employed consultants at great expense to advise that the only way forward is to charge for Let us have your views as quickly as possible as time parking on the road and put up charges in the car parks. is short. I may be stupid, but even I can see that this move will not be popular and will cost a fair amount of money.

The report that went to the Borough Council actually included 30,000 'fines' for parking to provide £900,000 income to the Council.

If you are really interested:

Total implementation cost is £659,000 with total annual operating costs £929,000, leaving a deficit of just £270,000, but the annual income is expected to be almost £2,000,000 (providing we all just ignore the regulation as we do now and get caught together with 'selling' more parking permits than actually available!)

It looks as though this is another cunning plot to 'balance the books' by the Borough Council. They have a problem with national government trying to 'redistribute' money from district councils who manage their affairs well, to district councils who don't. It just so happens that ours is one of the 'haves' having to give to the 'have not's'. It is much easier than having to raise income tax to do it I suppose.

As you all know, Traffic Wardens, along with the Police, are paid for by Herts County Council and thus directly by us via the Council Tax. A tinny weensy problem is that parking fines actually go to the treasury coffers and is the reason why we only have one warden in the town. Now, the plan is to 'decriminalise parking to allow the Borough Council to control all on-street parking within the Borough which has the beautiful side effect of allowing the Council to keep parking fines.

The logic goes along the following lines:

we have a shortfall of income; we have a parking problem; we could make it difficult to park and collect Corrections to last issue parking fine money instead of it going to the treasury; sell more permits than spaces available; bring in outside None that anyone has spotted yet! enforcement with a 'profit motive'; income goes up to We welcome all your suggestions and contributions, cover shortfall taken by national government and we so why not contribute? have the perfect excuse - you asked for better parking facilities - and we don't get the blame!
