## The General Data Protection Regulation 2018 (GDPR)

The GDPR, the General Data Protection Regulation, comes into effect on 25<sup>th</sup> May 2018. As a result the Association needs your explicit permission to continue to send you information. The purpose of the new Regulation is to protect you from receiving unwanted communications.

To continue to receive information from the Association we need your permission to use your Postal address, your Telephone number, and/or your E-mail address. Many of you have already responded. Thank you. A copy is attached for those yet to respond.

It is not solely this Association that must comply with these new changes. Any organisation that contacts you must obtain your specific permission.

The Association only uses your personal data for the purposes of informing you of news and events relating to Berkhamsted and its surroundings. We will never disclose any personal data to a third party.

You are able to withdraw your consent to storage, processing and use of your data by the Association at any time by e-mailing me at <a href="mailto:christopher.tp@hotmail.co.uk">christopher.tp@hotmail.co.uk</a> or by post to:

Paying a subscription is not a precondition of service. Even if you are a paid up member and do not return, or decline to give your consent, it will mean we will not be allowed to contact you, even with a newsletter. This is because the Newsletter may give details of forthcoming events. This counts as Marketing.

It seems only a few days since we gave the **Environment Award for 2017**. This year there was no plaque awarded, but a Certificate of Commendation went to each of:

8 New Road & Chandler Mews, Northchurch
– demolition of light industry and replacement with
6 new dwellings – to Atelier Architecture + Design

**Junction enhancement** – Kings Road / Kingshill Way/Shootersway – awarded to Herts Highways

Other topics covered by **Townscape** in the previous two months:

- Replacement trees for the High Street planting should have taken place by the time you read this:
- Multi-storey car park a meeting between the Parking Forum (our representative is Paul Crosland) and DBC officers was being sought;
- Northchurch and Dudswell Conservation Area Character Appraisal consultations – we have submitted responses to both;
- Reviewing and commenting on several applications in the conservation area, especially those concerning houses covered by Article 4 Directions or locally listed;
- Alerting the DBC conservation officer to listed buildings we feel are At Risk;
- Keeping track of Enforcement breaches.
